IAIS 2020-2021 Roadmap – Key considerations

Executive Committee Dialogue 2020

The IAIS has adjusted / prioritised its 2020-2021 Roadmap guided by the following key considerations:

- Alignment with the FSB principles on response to Covid-19 in particular:
 - Providing operational relief to Members and insurers, while at the same time not rolling-back the implementation of regulatory reforms or compromising the underlying commitment to the finalisation and implementation of key international standards;
- Relevance of projects for the IAIS' overall Covid-19 response;
- Whether projects are close to completion or already far advanced;
- Whether projects or activities contribute to the strategic pivot outlined in our 2020-2024 strategic plan; and
- Taking into account the broad interests of the IAIS diverse membership, with a particular focus on our Emerging Market and Developing Economy (EMDE) Members.



IAIS 2020-2021 Roadmap – Key updates 1/2

Executive Committee Dialogue 2020

Covid-19 Risk Assessment:

- Holistic Framework Global Monitoring Exercise (GME) refocused to enable timely monitoring of Covid-19 in 2020
- Risk dashboard of key market indicators

Covid-19 Policy Measures:

- o Information-sharing and analysis of Covid-19 related supervisory responses
- Deeper-dive analysis of identified priority topics

Collaboration with the FSB and other Standard-Setting Bodies (SSBs):

- Cross-sectoral risk assessment
- Supervisory responses to identified vulnerabilities
- o Intensified coordination and cooperation

Stakeholder engagement: In-person events in June (Global Seminar) and November (Annual Conference) cancelled and replaced with virtual programme



IAIS 2020-2021 Roadmap – Key updates 2/2

Executive Committee Dialogue 2020

Global Monitoring Exercise (GME):

 Reporting to the FSB and public on outcomes of 2020 GME postponed to October 2021 – data submission deadline extended to next year

Insurance Capital Standard (ICS), Aggregation Method and Comparability Assessment:

- Data submission deadline for participating Volunteer Groups extended to 31 October
- The Capital, Solvency and Field Testing Working Group (CSFWG) has increased its engagement with Volunteer Groups
- Public consultation on high-level principles for comparability criteria postponed to November 2020

Supporting material (Issues Papers and Application Papers):

- o Papers close to completion or far advanced will be finalised remotely
- o Public consultation in some cases deferred and/or consultation periods extended
